



Application for bursary support for music lessons

The Cheryl King Trust was established in memory of a former musician and popular Surrey Arts teacher. Cheryl was committed to providing opportunities for all children to learn about music regardless of background. The principal activity of the Trust is to offer financial bursaries to enable pupils, who may not otherwise be able to do so, to have or to continue with individual or group instrument or singing lessons. The bursary scheme is open to young people under 18 in Surrey who are learning musical instruments or singing and have been nominated by their teacher.

Applications can be made at any time during the academic year. If your application is accepted, you will be informed in writing, and arrangements will be made for The Cheryl King Trust to pay an agreed contribution for the cost of music lessons to the end of the current academic year. In exceptional cases applications will be considered for periods shorter than the remainder of the academic year.

The teacher will forward pupil progress reports to the bursary at the end of the summer term and applications to continue funding in subsequent years will be dependent on these being satisfactory. There are limited places available, and each application is assessed on its merits by the bursary.

The Trust will usually award bursaries covering 50% of the lessons with families or guardians expected to provide the other 50% of the cost. Annual gross combined family income should normally be at or below £30,000. Applicants are unlikely to be eligible if annual gross family income exceeds £40,000 except in very exceptional circumstances, or where government or other public funding for lessons is readily available (for example, through Surrey Arts).
